SUMMARY

Dr. Matthew Mendel is a clinical psychologist and expert witness with a private practice in Raleigh, North Carolina. He is the author of *The Male Survivor: Impact of Sexual Abuse* (Sage Publications, 1995). He has been retained in over 190 forensic cases in eighteen states and in federal jurisdiction. Most of his forensic work is in death penalty cases in which it is known or suspected that the defendant was sexually abused or otherwise traumatized during his childhood. Dr. Mendel evaluates these defendants, with a focus on their childhood traumas, and then tells their story, helping those involved in the disposition of the case understand the individual accused of the crime. Dr. Mendel is a pioneer in "life-history" based forensic evaluations, as opposed to more traditional evaluations in the forensic field, which rely heavily upon psychological testing.
